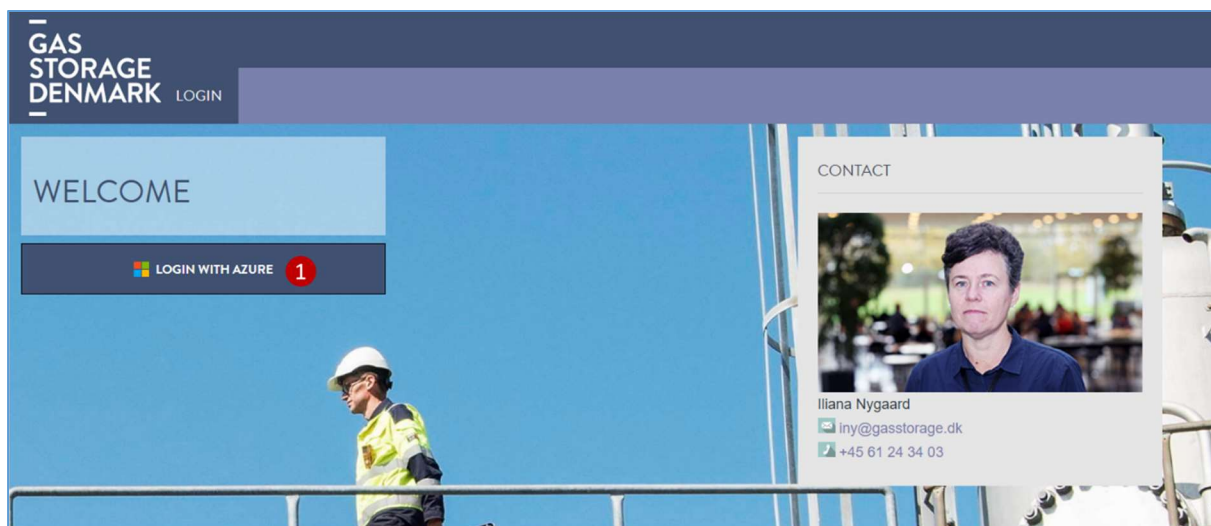


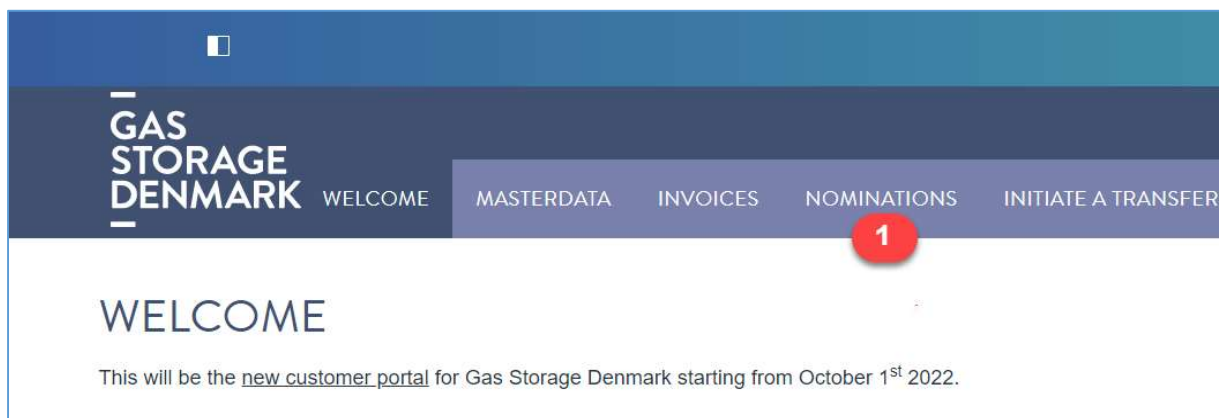


## GUIDELINES for NOMINATION through GSD CUSTOMER PORTAL

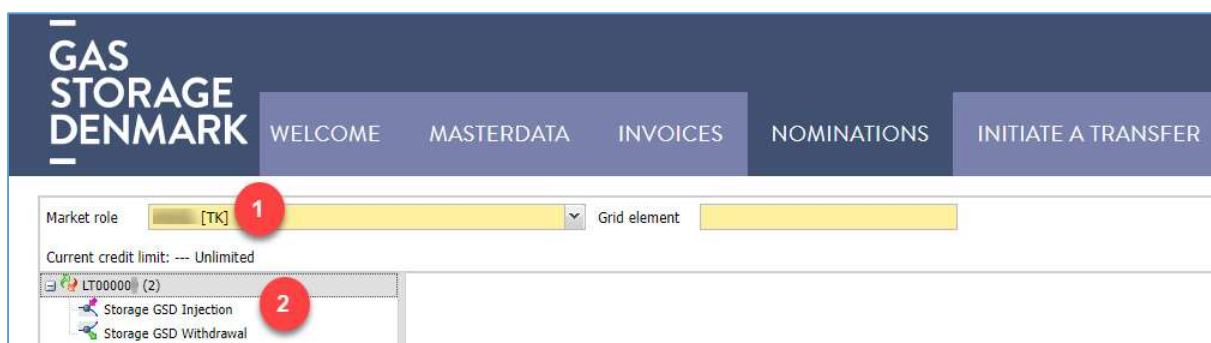
Open the Gas Storage Denmark Webportal: <https://customerweb.gasstorage.dk/>



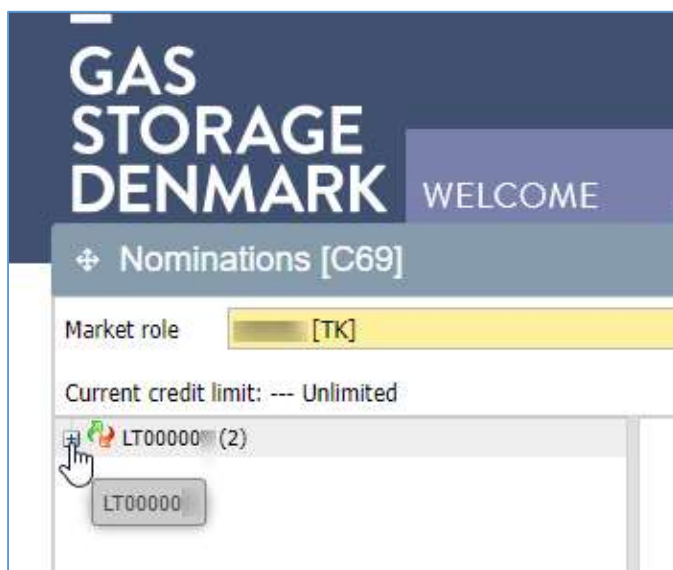
- (1) To login, use your MS Azure AD credentials by clicking on the button on the left side of the screen



- (1) Choose the NOMINATIONS tab



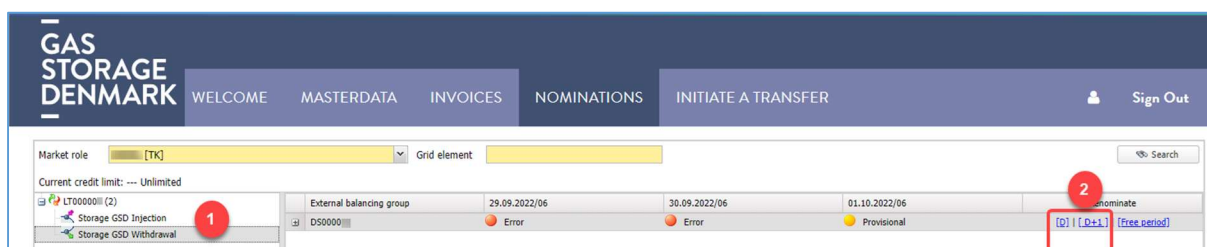
- (1) Check that your company short name appears in the field “Market role”  
(2) Check that your shipper code appears in the left side of the table



Klick on the “+” sign in front of the shipper code to open the two nomination directions for injection and withdrawal



Some storage customers may have multiple sub-accounts. In this case each sub-account will appear with own shipper code and the nomination should be performed for the relevant shipper code/sub-account



- (1) Choose either “Injection” or “Withdrawal” as appropriate
- (2) Use either [D] or [D+1] for renomination today [D] or nomination for gas day tomorrow [D+1].

▶▶▶ Please avoid using [Free period] at the beginning as it will not work properly right after GO-LIVE ... we are working on it.

To nominate, please observe the following steps:

- (1) Check you are on the right shipper code “Balancing group”
- (2) Check you have the right counterparty shipper code in the transmission system “External balancing group”
- (3) Check you have the right start and end date
- (4) Check that you recognize your booked firm capacity in the column “Declaration”, unit “kWh/h”
- (5) Enter your hourly nomination manually or by using the arrow(s)
- (6) Choose “Send nomination”

▶▶▶ Please note that it takes more minutes to nominate in the very beginning after GO-LIVE ... we are working to speed the process.

▶▶▶ If you have already nominated for the gas day in question and your nomination has been matched with the corresponding nomination for the transmission system, the cells in column “Nomination” will be populated with your matched nomination.

▶▶▶ If you have already nominated for the gas day in question and your nomination is waiting to be matched, the cells in column “Nomination” will show 0 (zero).

- (1) After sent nomination, you may click on the “+” sign in front of the shipper code to open the message view in order to see status – e.g. “Imported” which means the nomination has been sent to ESMS (GSD’s Energy Storage Management System) and later “Exported and confirmed” which means your nomination is now imported and accepted by ESMS
- (2) Use the “Search” button to refresh the view to see status “Exported and confirmed”

▶▶▶ Please note that red bullets with “Error” for the gas day will appear insofar it has not been nominated yet. After nomination, the color will change to orange “Provisional”.
