By giving at least 30 (thirty) days' notice Gas Storage Denmark shall communicate to the Storage Customer any amendments that are to come into force at the end of the said notice period .

## 9. Acceptance of the Rules for Gas Storage

In concluding this Storage Customer Agreement the Storage Customer accepts the version of RGS applicable at any time.
