If the Storage Customer's Shipper Code is mentioned first in the Shipper Code Pair, the Storage Customer is entitled to nominate the withdrawal of Natural Gas from the Storage Point using the Shipper Code Pair. If the Counterparty's Shipper Code is mentioned first in the Shipper Code Pair, the Storage Customer is entitled to nominate the injection of Natural Gas into the Storage Point using the Shipper Code Pair.~~

If the Counterparty's Shipper Code ("DSxxxxxx") is mentioned first in the Shipper Code Pair, the Storage Customer is entitled to nominate injection of Natural Gas into the Storage Point.~~
