3.3 In case there are multiple sub-accounts notified in clause 3.2 above and GSD reduces the Storage Customer's Total Nomination for all sub-accounts in an Hour, the reduction shall be allocated among the sub-accounts in accordance with one of the following two principles:

Pro rata, where the Nominations shall be reduced in proportion to the received Nominations per Shipper Code; or

Prioritised, where the reduction shall be allocated to the Shipper Code listed last in clause 3.2 above, until there is no more reduction to allocate, or the Nomination has been reduced to zero (0). Any remaining not allocated reduction shall be allocated to the Shipper Code listed second last in clause 3.2, until there is no more reduction to allocate, or the Nomination has been reduced to zero (0), and so on until the reduction has been fully allocated. The Nomination for Shipper Code listed first in clause 3.2 will be reduced last.

#### 4. Online Procedure for ordering storage capacity

The Storage Customer has chosen to have access to the Customer Portal:  Yes  No

Through the Customer Portal the Storage Customer has access to own storage data and the options to: (a) nominate/renominate to Gas Storage, (b) book Firm Capacity on short-term, (c) initiate Transfers, (d) view own Data and Invoices, (e) publish announcement on the Bulletin Board and (f) administrate own uUsers. Terms and conditions for use of the Customer Portal are in accordance with GTCGS, cf. clause 5.11 and clause 6.4. To be able to access the Customer Portal, the Storage Customer must conclude an Online Agreement, Appendix 4 to GTCGS.

#### 5. Interruptible Capacity

The Storage Customer may use the following Maximum Interruptible Capacities:

The terms and conditions for using Interruptible Capacities are described in GTCGS clause 5.3. Used Interruptible Capacities are payable in accordance with GTCGS clause 9.1 b).

#### 6. Credit Limit

To be able to enter into Storage Agreements in accordance with this Storage-CustomerFramework Agreement, GSD has assessed the Storage Customer's credit worthiness based on documentation provided by the Storage Customer in compliance with GTCGS clause 17.

From the start date of this Storage-CustomerFramework Agreement, GSD has granted the Storage Customer a Credit Limit of DKK [X,XXX,XXX]. This Credit Limit is:

- Fully based on GSD's assessment of credit worthiness
- Partly based on GSD's assessment of credit worthiness and partly covered by provision of security
- Fully covered by provision of security

## 7. Termination

The Storage Customer may request changes to this ~~Storage Customer Framework~~ Agreement in accordance with GTCGS clause 4.2.

The Storage Customer shall accept amendments to this ~~Storage Customer Framework~~ Agreement necessary for this ~~Storage Customer Framework~~ Agreement to comply with the GTCGS version in force. GSD communicates any amendments that are to come into force to the Storage Customer with at least 30 (thirty) days' notice.

## 9. Acceptance of GTCGS
