2. Definitions

Unless otherwise expressly stated, capitalized words shall have the meaning defined in Rules for Gas Storage ("RGS") in the applicable version at any time.

3. Purpose and scope

By entering into this Online Agreement, the Storage Ceustomer will obtain access to GSD's Online System ("Online"), which enables the Storage Customer to:

- a) conclude Capacity Agreements for the purchase of Storage Capacity made available by GSD for purchase via Online;
- b) access to all the Storage Customer's concluded agreements with GSD (Storage Customer AgreementFramework Agreement, Nomination Agreement, REMIT, Filling Requirements and agreements for the purchase of Storage Capacity);
- c) perform transfer of Storage Capacity and/or Natural Gas in the storage;
- nominate and renominate injection of Natural Gas into the sstorage Facilities or withdrawal of d) Natural Gas from the <u>Sstorage</u> Facilities;
- e) access publish announcements in to the Bulletin board
- access to information regarding Master Data, Storage Account, Shipper Codes, Invoice, Bulletin f) board etc.

4. Two types of authorisation level

The Storage Customer's Users may be assigned one of the following two types of access to Online:

The Storage Customer may also identify Users authorised to view data in Online only.

All authorised Users and their type of authorisation are notified in the Users List<u>at the end of this</u>to this Online Agreement.

5. Authorisation of Users

The Storage Customer shall <u>submit fill in</u> names, titles, email addresses and mobile phone numbers of the Users who should have access to the Online system <u>by filling</u> in the template provided in <u>form of</u> the Users List<u>attached to</u> to this Online Agreement.

Further, the Storage Customer shall specify the authorisation type of each User:

- a) Administrator; or
- b) Read only.

The Users shall be employed by the Storage Customer<u>and authorized to act on behalf of the Storage</u> <u>Ceustomerat all times</u>.

In case of <u>Nn</u>omination<u>s/Renominations</u> carried out by a Third Party providing 24<u>/7hr orand</u> out of office hours dispatching operations on behalf of the Storage Customer, the Storage Customer may authorise Users employed by such Third Party with user access to Online.

Storage Customer shall promptly notify GSD if the employment of any registered User ceases.

Further, the Storage Customer is obligated to inform GSD in case the Storage Customer wants to change the type of the authorisation of a User.

6. Maintenance of Users and Users' authorisation

If the Storage Customer wishes to add new User(s) or update existing User(s), the Storage Customer shall fulfil and submit the Users List attached to this Online Agreement with the appropriate information and send the Users List to GSD as a PDF file attached to an email <u>and-sent</u> to contact@gasstorage.dk.

7. Access and security

Upon the signing and submission of this Online Agreement to GSD, the specified User(s) in the Users List will receive a notification from GSD's Back Office containing alogin information (User ID & Password) User ID, password and guidelines for information, how to access Online.



The the User's User ID and the password arelogin information is strictly personal and may only be used by the relevant User and may not be disclosed to anyone else. The Storage Customer is liable for all data registered through Online.

8. Limitations to Online

GSD may add or remove information or services available through Online or limit the Storage Customer's use of the services. For instance, GSD decides how much Storage Capacity can be marketed via Online and the corresponding delivery period of the marketed Storage Capacity. Limitations may include restrictions to the types of transactions.

9. Limited liability of GSD

GSD is only liable for loss incurred by the Storage Customer from using Online if such loss is due to material negligence on the part of GSD, and the Storage Customer has informed GSD of the problem causing such loss without undue delay. Furthermore, the provision <u>of RGS under C</u>clause 20, Termination and damages, <u>under the RGS</u> shall apply.

FurthermoreIn addition, GSD cannot be held liable for the completion of any losses incurred in connection with any Order(s), Transfer(s), Nomination(s)/Renomination(s) etc. or lack of acceptance of related Counterparties in case of transfer(s), placed by using Online. Thus, the Storage Customer shall continuously monitor whether any Order(s), Transfer(s), Nomination(s)/Renomination(s) etc. as set forth in celause 3 a) – f) are correct and confirmed by GSD.

In case the Storage Customer discovers any problems with <u>any</u>Order(s), Transfer(s), Nomination(s)/Re-<u>nomination(s)</u> etc. or <u>incorrect_lack of</u> acceptance of related Counterparties in case of transfer(s), the Storage Customer shall immediately contact GSD for assistance. GSD is not obligated to assist the Storage Customer if the Storage Customer has not reported a problem without undue delay or if the commencement time of the relevant Order(s), Transfer(s), Nomination(s)/Renomination(s) and acceptance <u>by-of</u> related Counterparties in case of Transfers etc. has <u>been exceededlapsed</u>.

Notwithstanding the above, GSD cannot be held liable for loss due to unavailability or lack of access to $Online_{\perp}$ or damage to any data stored through Online, regardless of whether GSD or any third party is responsible for the operation of Online.

10. Storage Customer's liability

The Storage Customer and the <u>Storage Customer's</u> Users are responsible for the confidentiality and <u>the</u> use of the <u>User ID and passwordlogin information submitted by GSD to each User</u> for accessing Online. Thus, the Storage Customer shall cover any loss incurred by GSD or any other Storage Customer caused by the improper use of <u>the the Storage Customer's Users'</u> <u>User ID and passwordlogin information</u>.

However, the Storage Customer shall not be liable for <u>any</u> loss<u>es</u> occurring after the Storage Customer or the User<u>has informed GSD that the User's account must be suspended</u> in accordance with the procedures set forth in <u>c</u>Clause 12 of this Online Agreement<u>has informed GSD that the User account must be suspended</u> if such loss is due to the improper use of Online after the Storage customer or the User has requested GSD to suspend the relevant User account.

11. Technical requirements

In order to use Online, the User shall have a web browser installed and have access to the Linternet.

12. Suspension of <u>U</u>user's account



The Storage Customer shall immediately inform GSD in case the Storage Customer becomes aware of any unauthorised use of a login information or receives any confirmation regarding Storage Capacity, Transfers etc. not ordered via Online by the Storage Customer.

The Storage Customer may at any time suspend a User's aAccount by sending an email to contact@gasstorage.dk followed by a phone call to GSD's contacts published on https://gasstorage.dk/Contact-and-communication. GSD shall not be considered to have been informed before GSD receives both the email and the telephone call.

The Storage Customer shall immediately inform GSD in case the Storage Customer (i) becomes aware of any unauthorised use of the <u>a login information or</u>User ID and password, (ii) receives any confirmation regarding <u>Storage</u> Capacity, Transfers etc. not ordered via Online by the Storage Customer_;

After receiving notification for unauthorised use observed by the Storage Customer, GSD shall promptly suspend the Storage Customer's relevant \underline{u} User <u>a</u>Account.

Furthermore, upon <u>the</u> suspension of the <u>uUserUser's</u> <u>a</u>Account, GSD shall send an email to the <u>Storage</u> <u>Customer's</u> User using the User's email notified in <u>the Users List attached to this Online Agreement.Appen-</u> <u>dix 1.</u> By sending the mail, GSD shall confirm the suspension of the User's <u>Aa</u>ccount and provide information about the time for the received request for suspension, which is the latest of either the receipt of the email or the telephone call as mentioned previously in this <u>c</u>Clause 12. Following the suspension, the Storage Customer and GSD may agree on issuing of a new <u>User account for the User.</u>Account for the <u>Storage Customer</u>.

13. Assignment

The Storage Customer's rights and obligations under this Online Agreement may not be assigned to a third party without GSD's prior written consent.

GSD may assign its rights and obligations under this Online Agreement to a third party which performs the gas storage activities pursuant to applicable law at that time or to a legal entity in the Energinet group which performs the gas storage activities.

14. Term of agreement

This Online Agreement enters into force when signed by both parties the Storage Customer and GSD.

The Online Agreement may be terminated by the Storage Customer without notice. Furthermore, the Online Agreement shall end if the Storage Customer's Framework Agreement is terminated.

15. Changes

This Online Agreement is subject to the version of RGS applicable at any time. In case of conflict between this Online Agreement and RGS, this Online Agreement shall prevail.

The Storage Customer shall accept any regular changes to this Online Agreement, which are necessary to keep this Online Agreement in <u>accordance compliance</u> to the version of RGS applicable at any time.

16. Venue and applicable law

This Online Agreement shall be governed by Danish law.

Any dispute or controversy arising from this Online Agreement shall be settled in accordance with clause 19 of RGS.
