Conditions for use of the Online Procedure are in accordance with RGS clause 6.4. In order to be

able to access GSD's Online System, the Storage Customer must conclude an Online Agreement, Appendix 5 to RGS.

## 5. Interruptible Capacity

The Storage Customer may use the following Maximum Interruptible Capacities:
